### Dear Judge McLaughlin:

This firm represents defendant Major League Soccer, LLC ("MLS") in the above-referenced matter. I am writing in response to the Court's June 19, 2015 teleconference and July 8, 2015 Order regarding the issue of subject matter jurisdiction. Enclosed please find an Affidavit for Nick Sakiewicz, which is subject to this Court's confidentiality order based on the June 19 teleconference.

As discussed in MLS's Memorandum of Law in Support of its Motion to Dismiss and during the June 19 teleconference between the parties, Major League Soccer, LLC is a Delaware limited liability company. Under Third Circuit law, "the citizenship of an LLC is determined by the citizenship of each of its members." Zambelli Fireworks Mfg. Co. v. Wood, 592 F.3d 412, 418 (3d Cir. 2010). Each Team within MLS is owned by MLS but is operated by an owner-operator that is a member of Major League Soccer, LLC. Pennsylvania Professional Soccer, LLC is the owner-operator that operates the Philadelphia Union MLS team, and is a Member of Major League Soccer, LLC. (See Fifth Amended and Restated Limited Liability Company Agreement of Major League Soccer, LLC, dated January 3, 2012, attached as Exhibit 1 to MLS MTD Mem. Law, at 1, Exh. A.) Pennsylvania Professional Soccer, LLC itself is a Delaware Limited Liability Company, and has its principal place of business at 2501 Seaport Drive, Switch House Suite 500, Chester, PA 19013. Per the enclosed Affidavit, as of the filing of the Complaint in the instant matter, Nick Sakiewicz is a citizen of the Commonwealth of Pennsylvania. Keystone Sports and Entertainment, LLC, a Delaware Limited Liability Company, is the sole "Unitholder" of Pennsylvania Professional Soccer, LLC. Mr. Sakiewicz holds 50% of the Class B Units in Keystone Sports and Entertainment, LLC. He was and still is the Chief Executive Officer and Operating Partner of both Keystone Sports and Entertainment, LLC, and Pennsylvania Professional Soccer, LLC. Pennsylvania Professional Soccer, LLC is a citizen of Pennsylvania because Mr. Sakiewicz is a citizen of Pennsylvania. Accordingly, MLS is itself a citizen of Pennsylvania, which defeats diversity jurisdiction in the instant case as Plaintiff is also a citizen of Pennsylvania.
