73. Narrative REPORT OF A PERSON WITH A FIREARM. UPON ARRIVAL OBSERVED SGT. FRETT SPEAKING TO THE SUSPECT. AS I EXITED MY MARKED POLICE VEHICLE, I OBSERVED THE SUSPECT ATTACK SGT FRETT WITH OUT WARNING. AS I ATTEMPTED TO ASSIST SGT. FRETT, THE SUSPECT REPEATEDLY PUNCHED, KICKED, AND PUSHED MYSELF, AND SGT. FRETT. DURING THE STRUGGLE I CALLED VIA POLICE RADIO FOR ASSISTANCE. AT WHICH TIME, OFFICER AMATO ARRIVED AND WAS ALSO PUNCHED, AND KICKED BY THE SUSPECT. AFTER A STRUGGLE WITH THE SUSPECT POLICE WERE ABLE TO RESTRAIN, AND HAND CUFF THE SUSPECT. HE WAS SEARCHED INCIDENT TO ARREST, AND APPEARED TO BE UNDER THE INFLUENCE OF C.D.S. E.M.S. ARRIVED, AND TRANSPORTED THE SUSPECT TO COOPER HOSPITAL. THE SUSPECT CONTINUED TO STRUGGLE TO GET FREE, BUT WAS RESTRAINED TO AN E.M.S. STRETCHER, ONCE AT COOPER HOSPITAL MEDICAL STAFF CONFIRMED THAT THE SUSPECT WAS POSSIBLY UNDER THE INFLUENCE OF PHENCYCLIDINE (P.C.P.) THE SUSPECT WAS TREATED, AND TRANSPORTED TO CENTRAL COMPLAINT, TO BE PROCESSED.
