Dear Mr. Walsh:

Thank you for writing to the City Council of Philadelphia ("the City Council") with your request. At the outset, please be advised that requests for records to state and local agencies in Pennsylvania are generally governed by the Pennsylvania Right to Know Law, 65 P.S. § 67.101, et seq. (the "Act").

On April 9, 2014, the City Council received your requests for the following information:

"I'm requesting details on proposed City Council spending for FY2015. Specifically, I'm requesting a breakdown of proposed Class 100 spending for each City Council member's office for FY2015.

I'm also requesting explanations as to what the proposed spending for Class 200, Class 300, Class 400, Class 500, Class 800 and Class 900 would fund. Copies of any documents, records, communications or other information that explain why City Council is requesting these funds or what the funds would support would be responsive to this request."

A copy of your request is attached. This letter constitutes the City Council's response to your requests.

On April 17, 2014, the City Council sent you a letter notifying you that it needed an additional 30 days to review and respond to your request.

Your request is granted, insofar as the records exist. Attached please find records responsive to your request.

After a review of its files, the City Council has determined that it does not have some records responsive to your request. The City Council does not keep separate lists of expenses for each individual council office. Instead, the City Council does one overall budget each year which encompasses all council offices and other expenses. City Council does not budget individually for staffing levels. Additionally, City Council does not regularly keep its records in the format that you requested them.

"It is not a denial of access under the Act if the records requested do not exist. *Cf. Jenkins vs. Pennsylvania Department of State*, Docket No. AP 2009-0065 (OOR April 2, 2009)." Moreover, the City Council is not required to "create a record which does not currently exist or to compile, maintain, format or organize a record in a manner in which [the City] does not currently compile, maintain, format or organize the record." 65 P.S. § 67.705. The City Council reserves its rights to assert bases for denial if additional responsive records are located after a review of such records.

Nevertheless, even though the City Council is not legally obligated to create records to fit your request, Council has taken the time to break its budget down into the separate sub-categories as requested, and has furnished these newly created documents for your convenience. It is impossible to attribute dollar amounts in each sub-category to an individual council office, since all contracts are entered into, and supplies, equipment and materials, are purchased on behalf of the entire Council and distributed as needed. In any event, City Council, by providing these documents, does not waive any of its legal rights under the law.

Should you wish to contest any part of this decision, you may file an appeal with the Office of Open records as provided for in 65 P.S. § 67.1101. You have 15 business days from the mailing date of this response to challenge the City's response. Please direct any appeal to the Office of Open Records, Commonwealth Keystone Building, 400 North Street, 4th Floor, Harrisburg, PA 17120-0225.
